### AET L4 APPLICATION FOR APPOINTMENT AS A CHIEF MARKER OR MARKING MODERATOR: 2019 – 2021

### GENERAL

- 1.1 Application by lecturers for Appointment as a Chief Marker/Marking Moderator for the 2019-2021 Adult Education and Training AET L4 Examinations (ANNEXURE 1).
- 1.2 Applicants are required to carefully read all instructions on the application form.
- 1.3 All officials must check the Application Forms carefully and verify that only application forms for competent and qualified lecturers undergo the final processes (Shortlisting and Interviews).
- 1.4 Application forms are to be handed in at the Education District Offices Exams Unit.

- 1.5 Verification and sorting process will be done at the Centre and District levels by appropriate Verification Committees.
- 1.6 Chairpersons of the verifying committees must ensure that all documents required have been attached by each applicant. A checklist is attached to the Application Form.
- 1.7 Chairpersons of District Verification Committees must also verify if applicants teach the learning areas they are applying to manage during marking.

### 2. WHO SHOULD APPLY AS A CHIEF MARKER OR MARKING MODERATOR

- 2.1 A lecturer may apply to be a Chief Marker or Marking Moderator of the Adult Education and Training AET L4 Examinations provided he/she has taught the Learning Area he/she is applying for in Level 4 during the period 2016 to 2018 and was either an Examiner, Setting Moderator, Chief Marker, Marking Moderator, Deputy Chief Marker or Senior Marker during this period.
- 2.2 A lecturer with a recognized three-year post school qualification which must include the subjects concerned at a second or third year level (In conjunction with 2.1).
- 2.3 Centre Management Team members who taught AET L4 during the period 2016 – 2018 and who have strong support staff that will manage the centers in their absence.
- 2.4 Lecturers who have any qualification beyond Grade 12 must include a transcript of results from the institution showing the courses and the year of study.
- 2.5 Lecturers must have taught the subject and obtained 80% pass rate between 2016 and 2018 in the Learning Area applying for.

### 3. WHO DOES NOT QUALIFY TO MARK?

- 3.1 Lecturers who never taught AET L4 during the period 2016 2018 in the Learning Area they are applying for.
- 3.2 Lecturers who were never appointed as Examiners, Setting Moderators, Chief Markers, Marking Moderators, Deputy Chief Markers or Senior Markers in the period from 2016 - 2018.
- 3.3 SBA Cluster Leaders and SBA Co-ordinators who are not teaching the Learning Area or do not have qualifications in the Learning Area they co-ordinate.
- 3.4 A lecturer who does not have at least three years of recent teaching experience at Level 4 in the Learning Area.
- 3.5 Officials employed in the Assessment and Examinations Chief Directorate.
- 3.6 Lecturers or officials involved in Examination Irregularities in 2016 2018.
- 3.7 Lecturers who are retired/dismissed.

### 4. VERIFICATION AT CENTER LEVEL:

- 4.1 Center Managers to convene a meeting with all participants and the Centre Management Team.
- 4.2 All application forms must be quality assured jointly at this meeting.
- 4.3.1 Complete the LIST OF APPLICANTS (ANNEXURE 2), that will be signed by each applicant and his/her Head of Department (HOD). The signed Attendance Register must be attached to the list of applicants.
- 4.3.2 The signing of the LIST OF APPLICANTS is legally binding. It certifies the accuracy, and takes ownership, of the information provided by all signatories.
- 4.3.3 Center Managers must present the list of applicants to the entire staff members before signing it.
- 4.3.4 Any false information on this document will result in the disqualification of all the participants in the verification meeting from being appointed as markers for two years.

### 5. INSTRUCTIONS TO CENTER MANAGERS

- 5.1 Approval must only be given by signing the form, if the applicant was/is responsible for the teaching of the Learning Area at Level 4 during the period 2016 – 2018.
- 5.2 Do not sign application forms for lecturers who are not teaching in your center.
- 5.3 NB: Center Managers must ensure that information provided on the application form is accurate and verifiable.

### 6. VERIFICATION AT DISTRICT LEVEL

- 6.1 Members of the <u>Verification Committee</u> to verify the application for AET L4 Chief Markers and Marking Moderators will include:
- 6.1.1 CES: Curriculum (Chairperson).
- 6.1.2 CES: Governance.
- 6.1.3 DCES: Assessment & Examinations
- 6.1.4 Education Development Officer (EDO)
- 6.1.5 CET: Regional Official
- 6.1.6 Teacher Union representatives as observers
- 6.1.7 NB: Make sure that all criteria are met and information provided is verified. Reasons must be written in the space on the application form in the event of an applicant being not recommended.

### APPOINTMENT AT HEAD OFFICE

- 7.1 Members of the <u>Verification Committee</u> to verify the application for AET L4 Chief Markers and Marking Moderators is as follows:
- 7.1.1 CES: Marking Processes and Marking Processes Officials.

- 7.1.2 CES Instrument Development.
- 7.1.3 CES Internal Assessment.
- 7.1.4 Human Resource Administration.
- 7.1.5 Head Office Curriculum Official.
- 7.1.6 CET: Regional Official.
- 7.1.7 ECCET: Deputy Principal Academic.
- 7.1.8 Teacher Union representatives as observers.

### 8. CRITERIA FOR APPOINTMENT

- 8.1 Appointed Chief Markers and Marking Moderators must have attended all professional development and training programs and have a proven track record of excellence in the Learning Area applying for and must attach references.
- 8.2 Lecturers must have obtained at least 80% pass rate in the Learning area applying for in the 2016 2018 Examinations.
- 8.3 A copy of an Appointment Letter as Examiner, Setting Moderator, Chief Marker or Marking Moderator; and a short resume` must be attached.
- 8.4 At Least 3 years of recent teaching experience in the Learning Area during the period 2016 – 2018.

### 9. CRITERIA FOR REJECTION

- Incomplete or illegibly completed application forms will not be considered.
- 9.2 Application forms received at the Districts Office after the closing date will not be considered.
- 9.3 No application forms will be accepted at the Provincial Head Office. All applications must be submitted through the District Office for verification at District level.
- 9.4 Lecturers who obtained less than 80% pass rate between 2016 -2018 in the Learning Area applying for.
- 9.5 Failure to attach the appointment Letter as Examiner, Setting Moderator, Chief Marker or Marking Moderator; and a short resume.

### EXTRACT FROM GOVERNMENT GAZETTE, 12 FEBRUARY 2016 [No. 39684 Page 143-145] CRITERIA FOR THE APPOINTMENT OF EDUCATORS FOR EXAMINATION-RELATED WORK (MARKERS)

- (1) Markers (including Senior Markers, Deputy Chief Markers and Chief Markers) are appointed in terms of the Personnel Administration Measures (PAM), which states among other, the following: -
- (2) A recognised three-year post school qualification which must include the subject concerned at secondary or third year level or other appropriate post grade 12 qualifications.
- (3) Appropriate teaching experience, including teaching experience at the appropriate level, in the Subject concerned.
- (4) Preference should be given to serving educators who are presently teaching the subject concerned.

Please note: The Department reserves the right to reverse any appointment if there is evidence that the applicant has misrepresented him/herself by providing fraudulent or inaccurate information that is both work or academically related.
